Bucharest Stock Exchange

Bucharest Stock Exchange (BVB) is the institution located in the center of the local capital market ecosystem, being the only operator of securities markets in Romania. BVB manages two distinct markets on which are listed a variety of financial instruments shares, bonds, fund units, certificates, structured products, preference rights. At the end of July 2021, 84 companies are listed on the regulated market of BVB, with a total capitalization of RON 200 billion and 294 companies are listed on Multilateral Trading System (SMT) addressed to small and medium companies, with a total capitalization of RON 12.5 billion. Between January and July 2021, trading volumes on Bucharest Stock Exchange exceeded RON 10.5 billion, corresponding to an average daily liquidity of RON 81 million.

BVB Group also includes the Central Depository, the institution responsible for registry and settlement operations in Romania, and starting with October 2019, the Central Counterparty, CCP.RO was established as an institution that will take over the function of clearing transactions in securities in Romania, aimed at relaunching the derivatives market.

The first half of 2021 brought a record in terms of financing and listings on the BVB platforms, 28 Romanian companies attracting over RON 5 billion through issues of shares or bonds. The positive evolution of the Romanian capital market in recent years is also highlighted by the recent promotion to the emerging market status by FTSE Russell, a promotion that will increase the visibility and attractiveness of the local market among international institutional investors.

PROGRAMME OVERVIEW

The Programme raises the awareness on the understanding of the corporate governance law & practice in a national and international context.

Although many responsibilities look the same, being a board director is a very different role from being an executive director. To successfully carry out a board mandate, directors must have a broad overview of the company's operational activities, its governance structure and a deep understanding of its strategic direction and exposure to risk.

While program is designed for companies listed or prepared to be listed, it well suits to Directors in financial institutions.

CAPSTONE EXAM – A BOARD MEETING SIMULATION

The Programme will be delivered by a team of lecturers/facilitators, who are high caliber professionals in the respective areas.

Lecturers/facilitators will follow a standard study material in "ppt format" that includes a range of navigational, business cases and illustrative features aiming to ensure interaction with participants.

EXAMINATION AND CERTIFICATION:

During the study period there will be 6 milestones of progress: 5 online / offline group meetings and the capstone exam consisting in a board meeting simulation.

The **Evaluation Committee** will include 3-5 members of the boards representing the Bucharest Stock Exchange, and members from relevant regulatory bodies and industry representatives, and Envisia – Boards of Elite.

On the successful completion of the Programme, Envisia – Boards of Elite and Bucharest Stock Exchange will issue The Diploma of Excellence in Boards and Governance for Capital Markets and Listed Companies.
